

## Atami Infrastructure Management LLC Terms of Use of ETCX

### Article 1. Purpose

These Terms of Use provide for matters regarding information that should be made known with regard to the collection and receipt of toll fees by Atami Infrastructure Management LLC (hereinafter referred to as “Atami Infrastructure Management”) by using ETCX, which is provided by ETC Solutions, Inc. (hereinafter referred to “ETCS”).

### Article 2. Matters to Be Complied with

When you use ETCX on roads managed by Atami Infrastructure Management, you shall comply with these Terms of Use. If you do not comply with these Terms of Use, Atami Infrastructure Management may refuse your use of ETCX.

### Article 3. Procedures and In-vehicle Devices Necessary for the Use and Handling of ETC Cards

1. When you use ETCX, you shall take the procedures set forth in Article 3, item 1 of the ETC System Use Regulations, which are provided by the expressway company and other organizations pursuant to Article 2, paragraph (2) of the Ministerial Ordinance on the Handling of Collection and Receipt of Fees Using Automatic Toll Fee Receiving System (Ordinance of the Ministry of Construction No. 38 of August 2, 1999) and thereafter shall take procedures set forth in items 2 through 4 of the same Article.
2. The use of ETCX requires member registration with ETCX by the method predetermined by ETCS in addition to the procedures set forth in the preceding paragraph. The credit cards and ETC cards that may be used for member registration are specified based on agreements with ETC issuing companies, ETCS, and others.

### Article 4. Method of Use

1. When using ETCX, securely insert an ETC card into the in-vehicle device, confirm that the ETC card is in a usable state, drive in a lane where ETCX can be used in accordance with the operation guide display, signs, and the like, and stop at the side of a fee collection booth (a facility established at the tollgate to collect and receive fees where a fee collector is allocated; the same shall apply hereinafter).
2. When you pay a toll fee by ETCX, the fee collector at the tollgate will confirm your intention to pay the fee by ETCX. Please respond as follows:
  - (1) When you advance into a lane for ETCX and general payments (both ETCX and other payment methods such as cash and coupon tickets may be used for the same lane; the same shall apply hereinafter) with your ETC card inserted in the in-vehicle device, you will be deemed to have expressed your intention to pay the fee by ETCX. If you would

like to pay the fee in cash or by coupon tickets or the like, make sure to remove your ETC card from the in-vehicle device in advance.

#### Article 5. Restrictions on ETC Multi-purpose Use Service, etc.

1. Atami Infrastructure Management may restrict, change, or terminate the use of ETCX without notice, if it is necessary to do so for the management of facilities available for use of ETCX.
2. If it becomes difficult to operate the service provided by ETCS, credit card companies, or other organizations due to the equipment used to operate the service being maintained, inspected or being subjected to other technical work, the use of the service may be restricted.

#### Article 6. Matters to Be Noted for Passing through Tollgates

When you use ETCX and pass through a tollgate, you shall comply with the following items:

- (1) Drive in a lane on which ETCX may be used in accordance with the operation guide display, signs, and the like. If you enter a lane on which ETCX may not be used, you will not be able to pay the fee by ETCX. Pay the fee in cash or by coupon tickets or the like.
- (2) When you enter a lane at the tollgate, the vehicle in front of you will stop. Make sure to maintain the necessary distance from that vehicle and pay sufficient attention. It is not allowed to drive motorbikes alongside cars. Form a single line together with cars.
- (3) Slow down when passing through the lane at the tollgate, and make sure to stop at the side of a fee collection booth.
- (4) when the ETCX payment processing is completed, the fee collector will signal to you that the payment processing is complete. After checking that it is safe to do so, drive away slowly in your vehicle.
- (5) A fee collector may be required to confirm your vehicle's type if, for example, your vehicle has towing equipment. Please answer the fee collector's questions about your vehicle's type.

#### Article 7. Calculation of Fees

When you use ETCX, the fee prescribed by Atami Infrastructure Management shall be calculated based on the ETC card information and in-vehicle device information obtained by radio-wave communication between the ETC antenna installed at the tollgate and your in-vehicle device, and a record of your passing through the tollgate is kept by the recording equipment managed by ETCS.

#### Article 8. Disclaimer

Atami Infrastructure Management and ETCS shall not be liable for any loss or damage caused to users of ETCX failing to comply with these Terms of Use.

Article 9. Other

1. ETCX may be used on the toll roads listed in the left column of the following table with regard to the vehicle types listed in the right column of the same table:

Toll roads	Vehicle types for which ETCX may be used
Main lanes of the Atami Beach Line	Standard-size vehicles, light vehicles, two-wheeled vehicles (exceeding 125 cc), minibuses, large-sized vehicles

2. In the cases set forth in the left column of the following table, the handling method specified in the right column of the same table shall apply:

Case	Handling method
When a towing vehicle passes through	Stop at the side of a fee collection booth and notify the staff.
When applying for a discount for disabled people	Stop at the side of a fee collection booth and present the prescribed section of your physical disability certificate (you may also present a MIRAIRO ID).

3. Regarding the use of “Beach Line X Discount” for frequent users, see the Terms of Use of Beach Line X Discount separately provided.

Supplementary Provisions

These Terms of Use shall come into force on April 1, 2023.
